1.0 Introduction

This section provides the scope, purpose, background, and reference for the Oklahoma State Bureau of Investigation's (OSBI) Livescan interface.

1.1 Scope

This document is the only document that defines the interface described herein. This document, once approved, shall be the defining control document and shall not be changed or modified without the express written consent of the OSBI, and notated in this document. This document is to be used for law enforcement applications only.

1.2 Purpose

This document defines the interface specifications for a Livescan device that may be produced by any Livescan vendor today. However, the agency MUST purchase an OSBI Certified Livescan so that it will be fully integrated to the OSBI AFIS.

2.0 Description of Operational Concepts

The OSBI AFIS will be connected to the Internet in order to enable agencies with a NIST compliant Livescan and an Internet connection to submit NIST data to the OSBI.

3.0 Specifications

This section defines the specifications for the submitting Livescan.

3.1 FBI Certified Livescan

The Livescan system must be FBI/IQS (Appendix G) certified.

3.2 Information Captured

The Livescan device must be capable of capturing rolled impressions, plain impressions, upper and lower palm prints and mug shots.

3.3 Descriptor Data

All descriptor data must be formatted according to the OSBI Type-2 Record Specifications before being submitted from the Livescan to the OSBI.

3.4 Fingerprint Image Quality Transmission

All Fingerprint images transmitted from the Livescan must be NIST Type 4 (500 ppi) grayscale records as described in the ANSI/NIST-ITL 1-2011 NIST Special Publication 500-290 Edition 3.

Type 14 – Reference ANSI/NIST-ITL 1-2011 NIST Special Publication 500-290 page 68.

3.5 Palm Print Image Transmission

All Palm Print images transmitted from the Livescan must be NIST Type 15 variable-resolution Palm Print image records as described in the ANSI/NIST-ITL 1-2011 NIST Special Publication 500-290 Edition 3.

Upper and Lower Palm Print Images are required for Criminal Adult & Criminal Juvenile Submissions. The livescan shall capture and submit both upper and lower palm prints. Refer to NGI National Palm Print System (NPPS)

Table 1 describes the mandatory OSBI Type 15 logical record layout. For a complete description of these Type 15 fields and edits see Section 22 of the ANSI/NIST-ITL 1-2011 NIST Special Publication 500-290 Edition 3. **No Type 15**Palm Print images can be sent to the OSBI without also sending descriptor Type 2 and ten print Type 4 records.

3.6 Mug Shot Image Transmission

All Mug Shot and SMT (scars, marks, and tattoos) images transmitted from the Livescan must be NIST Type 10 facial & SMT image records as described in the ANSI/NIST-ITL 1-2011 NIST Special Publication 500-290 Edition 3. See the OSBI Mug Shot Interface Specifications for the complete description of mug shot requirements. **See section 1.3**

Mug Shot Images are required for all Criminal Adult & Criminal Juvenile Submissions.

3.7 Data Transfer Protocol

TCP/IP will be the protocol used for all file transfers, and network communications between the Livescan and the OSBI.

3.8 Email Transfer Protocol

SMTP (Simple Mail Transfer Protocol) will be the protocol used for all email exchanges between the Livescan and the OSBI.

3.9 Valid Email Account

In order to exchange email messages between the Livescan and the OSBI, a valid email account will be created by the OSBI and provided to the vendor.

3.10 Fingerprint Image Compression/Decompression

The Wavelet Scalar Quantization (WSQ) compression/decompression algorithm will be used for all gray-scale Fingerprint images transferred to and from the OSBI. For information regarding the WSQ algorithm refer to the Wavelet Scalar Quantization Grayscale Fingerprint Image Compression Specification, **refer to section 1.3 References**.

3.11 FBI Certified Printer

The Livescan printer must contain two card trays, print double-sided and be FBI/IQS (Appendix F) certified.

3.12 Rolls to Flats Comparison

In order to ensure correct placement of fingers, the Livescan must be able to compare rolled impressions to flat impressions. **This comparison must be minutiae-based.**

3.13 Fingerprint Processing

It is desired that the Livescan be able to perform image enhancements, extract minutiae and thinned images, and classify Fingerprint patterns before submitting data to the OSBI.

3.14 Printable Card Types

Due to the different types of cards that are submitted to different agencies, the Livescan must be capable of printing 5 different cards types. The card types are as follows: FBI Applicant, Oklahoma State Criminal, Oklahoma State Palm Print, Oklahoma State Filing Report Form, and Oklahoma State Disposition Report Form. Some cards / forms are required to be automatically printed once booking is completed. For further information on card types refer to Section 5.0.

3.15 OSBI OTN Check Digit Algorithm

The OSBI OTN is a 10-byte field, the first 9 bytes are numeric and the 10th is an alphabetic suffix used for calculating the check digit.

An edit should check for the first 9 bytes to be numeric, leading zeros could be added if less than 9 bytes are entered for this part of the field.

The following letters are used as suffixes and their corresponding position numbers.

It is calculated as follows:

Then pick the corresponding suffix based on the calculated value of Px. It should match the OTN number entered; otherwise it is an error condition.

For example: OTN = 000811547P

Digits 0 thru 7 above correspond with A1 thru A9

According to the formula:

$$f = [(512 * 0) + (256*0) + (128*0) + (64*8) + (32*1) + (16*1) + (8*5) + (4*4) + (2*7)] MOD 11$$

 $f = 630 MOD 11 = 3$
 $P_x = 11 - 3 = 8$

The letter corresponding to 8 is P, this matches the one entered, therefore it is a correct entry.

4.0 Types of Transactions

This section describes the types of transactions that must be available on a Livescan device. The particular type of transaction is identified in the Type Of Transaction (TOT) Field in the Type-1 record that is used with each transaction. For further information about a Type-1 record refer to the American National Standards Institute (ANSI), Data Format for the Interchange of Fingerprint Information, ANSI/NIST-ITL 1-2011 NIST Special Publication 500-290 Edition 3. Table 2 lists the types of transactions that are accepted by the OSBI. Table 3 lists the types of transactions that are not accepted by the OSBI.



LV transaction type will be used when booking a criminal over 18 years of age.

LV Data Flow Narrative


- The TOT for this transaction = LV

 valid Offender Tracking Number (OTN) using the OSBI OTN check digit algorithm as
 described in OSBI OTN Requirement Section 3.15.
- After the OTN number is generated, the Descriptor data, Fingerprints, Upper and Lower Palm Prints, and Mug Shots are required for submission.
- Once the data is captured and the booking is complete, the Livescan will transmit the NIST record electronically to the OSBI.
- Local printing of Fingerprint and Palm Print cards will also take place at this point.
- Filing and Disposition Forms MUST BE automatically printed once booking is completed.
- At this point, the information will be searched at the OSBI and OSBI AFIS Search Results will be e-mailed back to a dedicated mailbox assigned to each livescan.

- The Livescan MUST retrieve the search result via E-Mail and display result of a "Hit", "No-Hit" or "In-Progress" Response on the Livescan.
- If the search produces a Hit Response, the email will contain the SID number. The livescan shall have a capability to print out the OSBI Hit / No-Hit Response Form, refer to Section 5.10 OSBI Hit / No-Hit Response Form.

4.2 LVJ Transaction (Criminal Juvenile)

LVJ transaction type will be used when booking a criminal under 18 years of age.

 valid Offender Tracking Number (OTN) using the OSBI OTN check digit algorithm as
 described in OSBI OTN Requirement Section 3.15.
- After the OTN number is generated, the Descriptor data, Fingerprints, Upper and Lower Palm Prints, and Mug Shots are required for submission.
- Once the data is captured and the booking is complete, the Livescan will transmit the NIST record electronically to the OSBI.


- Local printing of Fingerprint and Palm Print cards will also take place at this point.
- Filing and Disposition Forms MUST BE automatically printed once booking is completed.

4.3 LVA Transaction (Police Applicant)

LVA transaction type will be used when processing police applicants or personnel at the local agency or for other law enforcement agencies.

Do not use an OTN from the OSBI provided OTN block for this TOT.


- The TOT for this transaction = LVA
- Descriptor, Fingerprint, Upper and Lower Palm Prints are required and will be captured at this point.
- Mug Shot is not applicable.
- Once the data is captured the transaction is complete and all data is transmitted electronically to the OSBI. Local printing of Fingerprint and Upper and Lower Palm Prints cards will also take place at this point.
- At this point, the information will be searched at the OSBI and OSBI AFIS Search Results will be e-mailed back to a dedicated mailbox assigned to each livescan.
- The Livescan MUST retrieve the search result via E-Mail and display result of a "Hit", "No-Hit" or "In-Progress" Response on the Livescan.
- If the search produces a Hit Response, the email will contain the SID number. The livescan shall have a capability to print out the OSBI Hit / No-Hit Response Form, refer to Section 5.10 OSBI Hit / No-Hit Response Form.

4.4 LVCW Transaction (OSBI Handgun License)

LVCW transaction type will be used when processing OSBI Handgun License applicants.

Do not use an OTN from the OSBI provided OTN block for this TOT.



4.5 LVN Transaction (Criminal Inquiry)

LVN transaction type will be used when processing Criminal Inquiry.

This transaction will NOT need to have the OTN number.

- The AOL (Arrest Offense Literal) must be = Criminal Inquiry


- NO OTN is needed.

4.6 LVNR Transaction (Criminal Non-Reportable Offense)

LVN transaction type will be used when booking a criminal who has been arrested for non-reportable offense.

- This transaction <u>WILL NOT BE AUTOMATICALLY SENT</u> to the OSBI and <u>the system shall</u> not allow the user to send the transaction manually at any time to the OSBI.



- This transaction <u>WILL NOT BE SUBMITTED</u> to OSBI at the end of the transaction and the system shall not allow the user to send the transaction manually at any time.








