

Crime in Oklahoma, 2020 Selected Findings, Murder

September 1, 2021

According to Uniform Crime Reporting requirements, murder is defined as "the unlawful killing of a human being in which the element of malice aforethought was present."

Any death due to a fight, argument, quarrel, assault, or in the commission of a crime is included. Manslaughters, suicides, accidental deaths, and justifiable homicides are excluded from this category.

In 2020, law enforcement agencies in Oklahoma reported 287 murders, a 15.3% increase from 2019.

Murder represented 1.6% of Violent Crimes and 0.2% of Index Crimes in Oklahoma. Of all murders, law enforcement reported 179 murders were cleared by arrest or exceptional means, resulting in a clearance rate of 62.4%.


In 2020, the highest number (30) of murders were reported in June and October. December had the lowest number of murders reported (15).


Figure 1. Murder, by Day of Week, 2020

Wednesday and Friday had the highest number of murders reported with 51 and 52, respectively (Figure 1). The day of the week with the lowest number murders was Thursday (33).

Of the 287 victims of murder, 70.7% were Male and 28.9% were Female. For the remaining victim, the sex was unknown.

For race and ethnicity, the victims were predominately White (56.8%) and Non-Hispanic (66.6%). Nearly half (47.7%) of the victims were between 15 and 34-years-old.

The victim-to-offender relationship was identified for 78.0% of victims.

For 17.8% of relationships, the victim and offender were in a familial relationship, and of those, 31.4% of victims were in an intimate partner relationship (one spouse killing another).

For non-familial murders, the most common relationship types reported included Relationship Not Determined (26.7%), Stranger (19.5%), and Acquaintance (19.1%).



In 2020, 69.3% of murders were committed with a Firearm, followed by Objects (14.3%), Other (8.7%), Chemical (3.8%), and Physical (3.8%) (Figure 3).

Of the 14.3% of murders committed with an Object, and of those, the most common weapon used was Knife or Cutting Instrument (73.2%).

The majority (81.9%) of murders had a circumstance that was not felony-related. Of those, the most common circumstance reported was Unknown Circumstances (31.1%).

Other common non-felony related circumstances included Other and Other Arguments (Table 3). For murders that were felony-related, the most common (18.1%) was Robbery.
